ORDER

As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2018-19 from colleges for courses affiliated to this University. The Principal, Govt. Medical College, Kollam-MM034 has submitted application for the continuation of provisional affiliation for the year 2018-19 vide paper read (2) above.

2) On verification of the applications it is found that the College has submitted necessary documents and remitted fee for continuation of provisional affiliation for the year 2018-19. Inspection was conducted in Govt. Medical College, Kollam-MM034 and inspection report was submitted vide read (3) above. The Scrutiny Committee meeting held on 10/04/2018 vide paper read (4) above, has scrutinized the inspection report and pointed out certain deficiencies in the college. The college vide paper read (5) above, has submitted the compliance report after rectifying the deficiencies pointed out in the inspection report. The Scrutiny Committee meeting held on 08/06/2018 vide read (6) above, has scrutinized the compliance report and recommended to grant continuation provisional affiliation to Govt. Medical College, Kollam-MM034 for the year 2018-19. The College vide paper read (7) above, has produced the letter of renewal permission for 2nd batch of MBBS course with 100 seats for the year 2018-19 from the Ministry of Health and Family welfare, Govt of India. The College has reconstituted the College Council for the year 2018-19.

3) The Hon'ble Vice Chancellor vide read (8) above, has accorded sanction to grant Continuation of Provisional affiliation to Govt Medical College, Kollam MM034 for conducting the course with an annual intake of students as described below during the academic year 2018-19 subject to ratification by the Governing Council and to the conditions detailed below. Governing Council vide



paper read (9) above, has ratified the action of the University to grant continuation of provisional affiliation to Govt Medical College Kollam MM034 for the academic year 2018-19.

- 1 i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 ii. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 iii. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

- 5 iv. Admission to the next academic year shall be made only after obtaining prior permission from the University.
