
Subject : Clarification regarding Recognition/Continuance of Recognition (CoR) for One Year .

It has been brought to the notice of UGMEB that there are certain previous batches of medical students, whose MBBS degree awarded by their respective Universities are yet to be recognized. Recognition or Continuance of Recognition for one year has already been granted by UGMEB in the year 2023 for the MBBS batch admitted in the academic year 2018-19(exiting in 2022-23).

2. Considering the peculiar situation and hardship faced by these medical students in obtaining permanent registration in the absence of recognized medical qualification, it is clarified that *Recognition/Continuance of Recognition granted by UGMEB for ONE YEAR in 2023 includes the MBBS batches admitted upto 2018-19.*

3. All Registrars of concerned universities and Directorates of Medical Education are requested to take appropriate action at their end.

Subject: Recognition of MBBS degree (100) seats granted by Kerala University of Health Sciences, Thrissur, Kerala in respect of the students being trained at Government Medical College, Kollam.

Sir,

I am directed to refer to your application for grant of Recognition of MBBS degree (100 seats), awarded by Kerala University of Health Sciences, Thrissur, Kerala in respect of the students being trained at Government Medical College, Kollam and to say that your college was assessed by the Assessors appointed by MARB to conduct virtual assessment during the final MBBS practical Examination on 10-11 & 16-17 May, 2022. The report of physical assessment is not available with UGMEB.

2. The above assessment report along with the data available on AEBAS and HMIS including CCTV footage was considered in Under Graduate Medical Education board (UGMEB) and certain deficiencies were noted. The same were communicated to college authority vide UGMEB's letter dated 16.05.2023 for compliance.


3. Since the response from the Principal, Government Medical College, Kollam was not received in specified time, an opportunity of the personnel hearing was also given to the college authorities on 21.06.2023.

4. After hearing the college authorities and careful consideration of the facts and compliance, it has been decided by UGMEB that Government Medical College, Kollam is granted **one year** Recognition of MBBS qualification in respect of the students admitted in the year 2018-19. However they shall apply afresh for recognition in 2024.

5. Accordingly the approval of the competent authority in UGMEB is hereby conveyed for grant of **RECOGNITION FOR ONE YEAR** for MBBS degree for 100 students, granted by Kerala University of Health Sciences, Thrissur, Kerala in respect of the students being trained at Government Medical College, Kollam.
6. However, the college authorities are advised to apply afresh to UGMEB in 2024 for Recognition, at least 6 (six) months prior to the final examination of MBBS Part II (Practical) along with requisite fee i.e. Rs.3.54 lakhs only.
